### QUESTION

To ask the Minister for Agriculture; Food and the Marine further to parliamentary question number 167 of 4 October 2017, if there was a disease outbreak or other incident resulting in extensive fish mortalities at a site (details supplied) previous to the recent jellyfish strike; the date his department and Inland Fisheries Ireland was notified of the disease outbreak or incident; the number of mortalities from this disease outbreak or incident; and the condition and number of the remaining fish at the time of the jellyfish strike. (Details Supplied) Marine Harvest's Roancarrig site in Bantry Bay

#### **REPLY**

My Department has been advised by the Marine Institute that the aquaculture site referred to by the Deputy experienced a disease outbreak in advance of the jellyfish strike.

On 21 September my Department received an inquiry from Inland Fisheries Ireland concerning large quantities of dead fish at the site referred to by the Deputy. Inquiries by my Department's Marine Engineering Division indicated that substantial mortalities had occurred.

The information requested by the Deputy in relation to the number of mortalities may be commercially sensitive and is also under consideration by my Department as part of a statutory process. Therefore it would not be appropriate for me to comment further pending completion of this process.

## QUESTION

To ask the Minister for Agriculture; Food and the Marine further to parliamentary question number 169 of 18 October 2017, if previous to 21 September 2017, the company complied with statutory instrument number 261 of 2008 Notification of Disease (2) (a); the action he has taken or plans to take if the requirements of the legislation were not met.

# **REPLY**

The Competent Authority responsible for the implementation of the Directive in Ireland is the Marine Institute.

The Marine Institute has confirmed to my Department that the operator of the aquaculture site in question has complied in full with the requirements of the Directive and Statutory Instrument No. 261 of 2008.

The mortalities at the site referred to by the Deputy have been caused in part by Cardiomyopathy Syndrome (CMS) and a jellyfish attack.

While my Department is satisfied that the notification requirements as specified in Statutory Instrument No. 261 of 2008 have been complied with, there are other notification requirements which form part of the terms and conditions of the applicable Aquaculture Licence. My Department is currently examining whether all the necessary notifications required by the licence terms and conditions have been fully adhered to. This examination is currently ongoing as part of a statutory process and, pending completion of this process it would not be appropriate for me to comment further.

Dear Michael.

Our Roancarrig fish were damaged by a bloom of the siphonophore, Muggiaea atlantica during week 35. We have counted concentrations of this small hydrozoan jellyfish in densities of 500 to 600 individuals at Roancarrig which has caused significant gill and skin damage in our fish. Hence the elevated mortality. Prior to this, blooms of Noctiluca scintillans and Radiolarians were recorded in the bay with the latter reaching concentrations of 180,000/m<sup>3</sup>. These plankters also caused gill damage to our fish which made them more susceptible to Muggiaea atlantica. As for the reports of wild mackerel mortality I cannot comment on the pathology but I suspect these blooms are to blame.
